YOU WILL BE REQUIRED TO SIGN A COPY OF THESE REGULATIONS PRIOR TO YOUR FIRST HUNT

- 1. Absolutely no hunting is allowed until hunt is paid in full. Members are responsible for the conduct of their guests at all times. Anyone under 18 years of age must be accompanied in the field at all times by a member who is at least 18 years of age.
- 2. Members are expected to exercise appropriate caution at all times while in automobiles or during transport.
- 3. Safe hunting is very important. While in the field, all persons must wear blaze vests, blaze hats and safety glasses. Rules prohibit ground shooting, shooting at low-flying birds, pass shooting and shooting in low visibility. Do not shoot across roads, ditches or anywhere the view is not clear. Please use extra caution if shooting in the vicinity of buildings, equipment or vehicles. The violation of any rule may result in the voiding of your membership without refund.
- 4. The consumption of alcoholic beverages is prohibited at all times on the field. It is a violation of State Fish and Game law to hunt while intoxicated. Hunting privileges will be revoked from anyone that management feels is under the influence of alcohol, or otherwise unfit to hunt. No alcohol is prohibited on the field at any time.
- 5. State Fish & Game laws apply on the Preserve. It is against Fish and Game Code to use an unplugged gun on a licensed game preserve, shoot from a vehicle or carry a loaded weapon in a vehicle. It is a violation of Fish & Game and State Law to pluck or draw birds, or otherwise litter the fields.
- 6. The use of magnum shells and reduced loads are not allowed. V1 Ranch does not allow the use of anything larger than a steel shot #6.
- 7. No one may hunt without a dog or a guide. If supplying your own dog, dog must be under complete control at all times. Dogs running out of control or wildly flushing birds will not be tolerated. Each dog handler or owner is fully responsible for the actions of his dog. Discipline of rental dogs is strictly prohibited.
- 8. Hunters are expected to keep all birds caught by their dog, as any dog-caught bird that is then released, will likely die within three days. Hunters must immediately follow-up on all wounded birds. When a bird is winged, stay with your dog until the bird is found. Leaving wounded birds without an honest attempt to retrieve them, or discarding unwanted or dog-caught birds, will result in the voiding of your membership without refund, and a citation for Waste of Game from the State Department of Fish and Game.
- 9. The State Fish and Game code requires that all hunters and their guests, personally and individually, sign-in and sign-out on each visit to the Club. It is against V1 Ranch rules for anyone to sign-in or sign-out for another person. All hunters, regardless of age, must have in their possession at all times, a valid California Hunting License.

- 11. In accepting membership, each member and/or guest agrees to allow his vehicle to be searched by the management, its agents, or Department of Fish & Game personnel. The violation of any Fish & Game or V1 Ranch regulation will be grounds for immediate revocation of membership without refund.
- 12. The undersigned member hereby agrees to abide by each and all of the foregoing rules and regulations, and to assume all responsibility for guests to do the same. The undersigned acknowledges that they have read and understand the foregoing rules and regulations and has been provided with a copy of them and that a violation of these rules and regulations will subject the undersigned member or guest to civil liability to anyone whose person or property is injured as a result. The undersigned member further acknowledges that hunting can be a dangerous sport, and hereby agrees to assume the risks associated thereupon and further agrees to assert no claims against V1 Ranch, landowners or employees for death or injury from accidents occurring to the undersigned or his property in or about V1 Ranch from any reason including willful or intentional misconduct, negligence or carelessness of V1 Ranch Preserve, landowners or employees of either of them.

The undersigned hereby agrees to defend, indemnify and hold V1 Ranch and all landowners on whose land the hunt is conducted, harmless against any and all like claims by guests of the undersigned.
